

Rules of Procedure - NSTTV AKRIS

These rules of procedure contain rules to support the statutes of the Nijmeegse Studenten Tafeltennisvereniging Akris. These statutes have been established in a notarial deed on May 19th 2016.

Article 1. Targets

1. Next to the targets named in the statutes, the association strives to have frequent non-table tennis related activities.

Article 2. Financial

1. If the board wants to substantially deviate from the yearly budget, this will be submitted to the General Members Meeting, unless the board deems it necessary for the financial health of the association.
2. The board is committed to keeping sponsorships and seeking new sponsorships if necessary, but only if the sponsorship aligns with the targets of the association.
3. The board makes sure there is a financial buffer to deal with financial setbacks. This buffer is equal to the largest depreciation of the last two years.

Article 3. Membership

1. Registration as a member happens with a membership form to the board.
2. When a prospective member is a student at a college or a university, they will be certainly accepted into the association. When a prospective member is not a student, the board will decide on the acceptance into the association.
3. If Akris gets fined due to misconduct of a member, the association is free to charge this fine on the person in question.
4. When during a sports card check shows that a member does not have a valid sports card, the member has to possess one within two weeks.
5. The Akris membership will be tacitly renewed every association year.

Article 4. End of Membership

1. Cancellation of the membership needs to be submitted by e-mail to the board. The cancellation needs to be received before October 1st. This will make the membership end at the end of the year the member has last paid contribution for.
2. When the validity of a sports card ends during the academic year, the member needs to inform the board. In this case the membership will be changed to a 'tientjeslidmaatschap' without added costs until the end of the year or when the member possesses a valid sports card again.
3. If Akris does not meet the Radboud Sports Centre's rules about the maximum number of non-student members, the board is authorised to deny the membership of non-student members. The board is free to make an exception if a member contributes to the targets of the association.

Article 5. Contribution

1. The yearly contribution is € 35,-.
2. If the member joins the association after February 1st, the contribution will be only € 20,-.

3. The contribution will be collected with direct debit. The members will be informed two weeks before the direct debit about the collection of the contribution.
4. A demand letter for payment of the contribution will be sent in the name of the board to the members who did not consent to the direct debit.
5. If a member has not paid the contribution fee after two months of the first demand letter, the board is authorised to deny the member access to the training and activities.

Article 6. Committees

1. Akris has, to support the board, as standard committees the activity committee, tournament committee, advice committee and the technical committee.
2. Next to the standard committees, the board yearly considers the lustrum committee. When the lustrum committee is formed, it will be determined for what term it will be formed and in which composition it will fulfill its role.
3. The board is authorised to appoint new committees.
4. With possible exemption of the lustrum committee, all committees remain assigned until the end of the association year. The board is authorised to change the composition of committees if deemed necessary.

Article 7. General Members Meeting

1. The board aims to have a yearly GMM in september. The half-yearly GMM will be held approximately half a year later.
2. The authorisation of another member for the GMM is possible by sending an e-mail to the board before the GMM. The authorisation is also possible by sending a written statement, which the authorised member will have to show to the board before the start of the GMM.

Article 8. Trainer

1. De trainer is lid van de technische commissie.
2. De trainer heeft dezelfde rechten als een normaal lid, met uitzondering van stemrecht op de ALV. De trainer is niet contributieplichtig en mag niet deelnemen aan de clubkampioenschappen, met uitzondering van de dubbel, indien hier een oneven aantal deelnemers is.

Artikel 9. Trainingen

1. Het bestuur brengt leden op de hoogte wanneer een training niet door kan gaan of indien er andere bijzonderheden zijn.
2. Een aspirant-lid heeft recht op drie keer vrijblijvend meetraineren bij de trainingen.

Artikel 10. Competitie en toernooien

1. Leden worden via het bestuur op de hoogte gebracht van de mogelijkheid tot deelname aan competitie.
2. De NTTB-contributies voor leden die competitie spelen wordt doorberekend aan de leden.

3. Een lid dat zich voor de najaarscompetitie heeft opgegeven, verlengt hierbij ook automatisch het lidmaatschap bij Akris.
4. De technische commissie zal op basis van de aanmeldingen voor de competitie een teamindeling maken. De competitie spelers worden op de hoogte gebracht van de teamindeling voordat deze officieel wordt ingediend bij de NTTB. Verzoeken tot wijziging dienen dan ingediend te worden bij de technische commissie binnen de opgegeven tijd. De technische commissie zal over de definitieve indeling beslissen.
5. Een lid dat voor het eerst competitie gaat spelen bij Akris, zal de helft van het competitie shirt moeten betalen. Wanneer het lid besluit een tweede competitie seizoen te spelen, krijgt dit lid ook de tweede helft van Akris.
6. De technische commissie bestaat uit de wedstrijdsecretaris, de trainer en een op de ALV te bepalen derde persoon die geen lid is van het bestuur.
7. De wedstrijdsecretaris zal de leden tijdig op de hoogte brengen over relevante toernooien. Aanmelding geschiedt via de wedstrijdsecretaris.
8. Iedereen die namens Akris deelneemt aan een toernooi, is Akris het door de toernooiorganisatie ingestelde inschrijfgeld verschuldigd. Akris vraagt hiervoor indien mogelijk deelnamesubsidie aan bij de NSSR, en vult deze subsidie indien nodig aan met een toelage vanuit Akris tot precies 50% van het inschrijfgeld. Akrisleden die geen recht hebben op deelnamesubsidie hebben recht op dezelfde toelage vanuit Akris.

Article 11. Tientjesleden en honorary members

1. Being a tientjeslid is only possible for former members and former trainers. Registration as a tientjeslid is only possible via the board.
2. A tientjeslid pays at least €10 a year.
3. If a tientjeslid has not paid in two months after the first demand letter of the treasurer, the board can deny the tientjeslid access to activities.
4. The membership of a tientjeslid will be tacitly renewed every association year. The membership of a tientjeslid can be cancelled by sending an e-mail to the board.
5. A tientjeslid will be kept informed about activities.
6. A tientjeslid will in principle be kept informed about relevant tournaments.
7. A honorary member that possesses a sports card has the same rights as a regular member. If the honorary member wants to play competition, they will have to pay the NTTB-contribution fees to Akris.

Article 12. The board

1. The board shirts will be compensated for 50% by Akris, after the presented shirts are accepted by the GMM.

Article 13. Final article

1. These rules of procedure can only be changed by the GMM.
